4. An affidavit stating that he has no previous criminal record and has not been subjected to any disciplinary action by the Head of the Institution.
5. A declaration duly signed by the candidate to the effect that he/she has not availed more than one opportunity to contest the JPUSU and has not contested even once for the posts of office bearers of the Students' Union.
6. An affidavit stating that he/she has not been convicted by any court of law; no criminal cases pending against him/her in any court of law; he/she has not been charge sheeted in any criminal case.


